## C I R C U L A R

Dear friends,

You are aware Joint National Convention of Central Public Sector Undertakings Workers of all the Central Trade Unions i.e., INTUC, BMS, HMS, CITU, AITUC and others jointly declared for One day Strike on 28<sup>th</sup> February, 2012.

In this connection the Indian Airports Kamgar Union served strike Notice dated 31.01.2012 to AAI management and marking copies for all concerned including to the Regional Labour Commissioner (C) at New Delhi. The Assistant Labour Commissioner (C) at New Delhi issued Notice to AAI Management and Indian Airports Kamgar Union by admitting the matter into Conciliation wherein hearing was fixed on 24-02-2012.

During hearing of case the detailed discussion took place between the Management and Union over the demands raised in the Union Strike Notice dated 31-01-2012, which was seized into Conciliation by the Conciliation Officer vide Notice 17-02-2012, further directed AAI Management to discuss with IAKU and amicably settle following demands: -

- b) Formulate Policy to getting AAI Employees of IGI Airport, Delhi & CSI Airport, Mumbai posted to their original workplace with lawful settlement and as an immediate measure for posting them at Delhi & Mumbai as far as possible.
- c) To initiate steps to take full control of Dr. Babasaheb Ambedkar International Airport, Nagpur and draw roadmap for its development by AAI.
- e) Immediately issue compassionate appointment orders to dependants of deceased AAI employees' family.
- f) Immediately to resolve issue of inter-se-seniority as per the recommendations of Expert Committee (Justice retired J.D. Jain) removing various disparities among AAI (IAD & NAD) Employees.
- g) Immediately to pay PLI/Ex-Gratia to Employees' for the year 2010-11 in lieu of profit earned by AAI.
- i) Notify AAI (General Conditions of Service & Remuneration of Employees) Regulation with mandatory approval of the Central Government.
- j) Immediate cancellation of "Medical benefits Scheme" & "Premature Retirement" HRM Circulars No. 01 & 02/2012, dated 17<sup>th</sup> January, 2012.

Further the attention of Union was drawn by the Conciliation Officer toward the provisions of I. D. Act, 1947 during pendency of Conciliation Proceedings as mentioned in the Notice dated 17-02-2012 and the Conciliation Officer fixed next date of hearing on 27-03-2012.
