Subject: -English News daily reports laxity in collection of bills AAI loses crores from Kingfisher and other Airlines — Enquire the reported serious lapses to punish guilty and fix accountability.

We found a English News daily dated 01st April, 2012 i.e., The Sunday Times carried a shocking News Clip as "Govt. loses crores as KF, others' cheques bounce" further revealing an RTI query reported that; "Kingfisher Airlines issued cheques to AAI beginning August last year, all of which bounced due to "insufficient funds". Laxity on part of AAI, which deposited the cheques after six months of them being issued for clearance, added to the loss.

It might not be out of place to mention that the finances of Airports Authority of India under severe threat as such AAI's reserves have been exhausted, FD's are being revoked prematurely, loans are being taken to pay salaries of employees. The payment defaults by some of Airlines caused much of severe financial threat to AAI.

At this juncture the media's claim laxity on part of AAI, if it is true, the action is very serious lapse, it seems the lapse is deliberate, which need to be enquired to find the guilty and fix accountability, whoever and how big he/she or they may be, from furthering any such serious lapses, to save AAI from anti-organizational activities.

We the Indian Airports Kamgar Union as a responsible Trade Union functioning in AAI will raise and fight every issue, which detrimental to the interest of our Organization. We assure our fullest cooperation for effective & competitive functioning of AAI.
